### **KEYNOTE**

The State of Play of Microcredentials in the EU

Prof. Mark Brown, Dublin City University - National Institute for Digital Learning



Professor Mark Brown is Ireland's first Chair in Digital Learning and Director of the National Institute for Digital Learning (NIDL) at Dublin City University (DCU).

Mark has served in senior leadership roles for the past 15-years at two top 100 ranked young universities and has over 25-years of experience working in blended, online and digital (BOLD) education. Before taking up his current position, Mark was Director of the National Centre for Teaching and Learning as well as Director of the Distance Education and Learning Futures Alliance (DELFA) at Massey University, New Zealand. In this role, Mark had strategic oversight of Massey's 18,000 online distance students and played a leading role in establishing Massey University Worldwide. His current role at DCU involves strategic leadership for all fully online programs delivered through DCU Connected, including joint oversight of the global strategic partnership with FutureLearn and plans to develop a suite of new stackable, creditbearing micro-credentials.

Professor Brown has served on DCU's Senior Executive Committee for the past 7-years and is a member of the Education Committee and Academic Council. Since taking up his position at DCU, Mark has led the development of the DCU Connected brand, the conception of, and ongoing enhancements to, DCU's virtual learning environment (Loop), and the University of Sanctuary Scholarship program for online students. In 2020, Mark served on the European Commission's Consultation Group for Micro-credentials and was previously involved in the Common European Framework for Micro-credentials as part of the European MOOC Consortium establishment. He is a Steering Group member (2021-2019) for the DigiEdHack, a key feature of the European Commission's Digital Education Action Plan. In 2019, Professor Brown was Chair of the ICDE World Conference on Online Learning hosted in Dublin.

Over the past 20-years, Mark has played leading roles in the business case development and implementation of several significant university-wide teaching and learning initiatives. This work has included the successful enterprisewide deployment of a new Learning Management System (LMS), the original design and development of the Mahara e-portfolio platform, the strategic planning of a major rich media learning system [Mediasite], and the first New Zealand implementation of a Massive Open Online Course (MOOC) platform [Open2Study]. In March 2020, in response to the Covid-19 crisis, Professor Brown was part of the team that developed a FutureLearn MOOC on How to Teach Online, which has attracted over 90,000 educators worldwide. In 2020, Mark led the development of a MOOC on learning how to learn online through FutureLearn, which attracted over 7,500 learners and achieved a 56% completion rate.

Professor Brown serves on several international journal editorial boards and has published extensively in BOLD Education. Mark has a successful record of securing external funding grants and has played leading roles in several significant national and European research and development projects. He is a past Chair (2014-2018) of the Innovation in Teaching and Learning Steering Committee for the European Consortium of Innovative Universities (ECIU) and plays a leading role in the new ECIU University. Professor Brown is an EDEN Fellow and the current Treasurer of the European Distance and e-Learning Network (EDEN). Mark serves on the Supervisory Board of the European Association of Distance Teaching Universities (EADTU) and continues to have strong links down under serving on the Executive Committee of the Open and Distance Learning Association of Australia (OLDAA). Before taking up his current position, Mark was President of the New Zealand Association for Open, Flexible and Distance Learning (DEANZ, now FLANZ). He was also Treasurer and an Executive Committee member of the Australasian Society for Computers in Learning in Tertiary Education (ASCILITE).

In 2017, the Commonwealth of Learning recognised Mark as a world leader in Open, Online and Distance Education. Mark is a recipient of a National Award for Sustained Excellence in Tertiary Teaching and remains a member of the New Zealand Academy of Tertiary Teaching Excellence. See for more information:


